company must maintain relationships with stakeholders and maintain t sustainability of the existence of resources so that the company grows sustainably along with the benefits for stakeholders and the balance of nature. To that end, companies must carry out Corporate Social Responsibility (CSR) activities as evidence of corporate responsibility to stakeholders and maintain the availability of sustainable natural resources. Therefore, the company will make environmental performance reports, namely Sustainability Reporting, and Financial Statements to shareholders and stakeholders. For this environmental performance, the government will give a rating in environmental management known as PROPER. This research was conducted to see whether the company's financial performance as measured by Return On Assets is influenced by CSR activities, and Sustainability Reporting for companies that have received PROPER ratings from the government. Research on 45 manufacturing companies listed on the Indonesia Stock Exchange during 2014-2015 shows that CSR activities do not affect financial performance, while Sustainability Reporting has an influence. Thus, manufacturing companies are expected to make CSR activity plans in line with the company's mission and objectives that are sustainable, and maintain the honesty of sustainability reporting as a control and reference tool to maintain the sustainability of the company's business.
