The appraisal of project financing PF options for construction small and medium enterprises (SMEs) in the Nigerian built environment necessitates this study due to the financial management issues encountered in providing solutions to emerging challenges _ management, risks, and opportunities for effective participation and performance of construction small and medium_sized enterprises. An extensive literature review was conducted to identify variable options, which were then classified into six (6) primary sources: commercial banking, traditional sources, non_financial institutions, modern financing arrangements, world bank related, and non_interest (Islamic banking) as requirements to develop a framework for the selection of appropriate PF options available for construction SMEs to determine the most suitable PF options. 219 questionnaires were analysed. Findings revealed that term loans are familiar with construction small, while medium enterprises are primarily familiar with overdrafts. These are among the options required in a framework developed for construction SMEs' selection of appropriate PF options.
